#### **Evaluation Statistics Report**

Dr. Sherban provided some background on the evaluation program and remarked in 2009, as part of school reform, we totally revised the process and, in 2015, we did some small revisions in collaboration with the Teacher's Union and the Administrator's Union. Some key aspects of our evaluation process is that it prioritizes coaching and developing of educators it is not just an evaluation process but an evaluation and development process. What is unique to our process is student growth, and the state incorporated it into their process as well. Dr. Sherban continued with a PowerPoint presentation.

Upon completion of the presentation, there was a question and answer period. Dr. Sherban answered Board members' questions in detail.

#### Student Disciplinary Infraction Data Report

Dr. Sherban stated that at the end of marking period one, we presented to the Board the suspension data as an aggregate and the Board requested we present a breakdown by the infraction category. These include all of the suspensions and all of the students for marking period one. She explained in detail.

Ms. Joseph-Lumpkin commented that this is a national issue; it is not unique to New Haven. We are working to address this problem not only in the schools but by engaging our community partners as well, in order to develop alternatives and diversionary programs to exclusion. She explained in detail.



Ms. Typhanie Jackson expanded on the national trend and explained that the Obama Administration, the Department of Justice and the Department of Education have come up with some joined guidance for school districts relevant to concerns on this issue. The Department of Education, under the direction of Ms. DeVos, has changed all that and some of the recommendations are no longer a requirement. Ms. Jackson continued to explain in detail.

Mr. Kermit Carolina emphasized to the audience that this is a very urgent issue. Mr. Carolina began by sharing some national data. He remarked that over the last five years our expulsion rates have decreased significantly. He explained in detail how this came about due in part to the YouthSTAT Program other youth organizations in the City and he thanked them for all their support in this effort. He then compared suspension rates between New Haven, Hartford, and Waterbury and by race/ethnicity and explained in detail. Mr. Carolina provided a list of barriers to success, such as abandonment, feelings of feeling unsafe, etc., according to Dr. Pedro Noguera, Distinguished Professor of Education at UCLA who goes around the country talking about this issue.

At the completion of the presentation a question and answer discussion with Board members ensued.

Mr. Goldson thanked the presenters. He called them a dream team and if anyone can get the job done they can.

Mayor Harp thanked the group and the work that they have done.

#### FY 2019-2020 Budget Proposal

Dr. Birks present estimated proposals for the 2019-20 FY. She thanked the team in advance for all their hard work. Dr. Birks gave statistics on students, school staff and then presented the budget process. Our expenditures are based on our priorities and she explained the priorities. With a PowerPoint presentation Dr. Birks explained in detail the profit proposal.

Ms. Keisha Hannans explained the funding history for FY 2016-17, 2017-18 and 2018-19. She explained this in detail.

Dr. Birks fielded questions by Board members. A discussion ensued.

Ms. Hannans concluded the budget report.

### Chief Operating Officer, Attorney Michael Pinto

Dr. Birks presented to the Board the new COO, Atty. Michael Pinto. He will be starting in March. Atty. Pinto lived in New Haven and attended New Haven Public schools. We are excited that he is on our team. He is currently transportation deputy director for the City.

Atty. Pinto thanked the Superintendent and commented that he is honored and humbled to be here. New Haven Public Schools have been part of his family's history since 1916. He recognizes the magnitude of this job and he would like to be pragmatic and he remarked he just wants to get the job done. He thanked them for bringing him home.

### Director of Head Start Ms. Elizabeth Gaffney

Dr. Birks presented the new Head Start Director, Ms. Elizabeth Gaffney. She is a native of New Haven and she will be joining our Head Start team. She has been teaching in Connecticut for 26 years. Dr. Birks continued with her credentials. She comes to us from New Britain as an instructional coach and we are extremely elated that she is joining our team.

Ms. Gaffney commented she is elated as well and she thanked them for bestowing this honor on her. As a former Head Start teacher she knows the importance Head Start plays in the lives of our students and their families and she will work hard every day to ensure that our children are receiving the best. Ms. Gaffney gave some personal information about her life in New Haven when she was young. She is thrilled to be back in New Haven and she feels she has come full circle. She looks forward to work with the Head Start staff.

### Summary of NHPS Advocates Forum Hot Topics in the NHPS: Who Can Serve on the Board of Ed?" Friday February 8, 2019, from 6-8 PM

This event brought together a diverse group of families, educators, and community members

There were about 45 people participating from 18 schools: Beecher, Betsy Ross, Career, Columbus, Conte, Davis, East Rock, Edgewood, Elm City Montessori, ESUMS, Fair Haven, HSC, Hooker, Mauro-Sheridan, Metro, Nathan Hale, West Rock, and Wilbur Cross

We were honored to have Dr. Tamiko Jackson-McArthur in the conversation

It started with a presentation on the composition of the Board of Education
