DISCUSSION ITEMS

- November 2019 Financial Report: Mr. Penn reviewed the financial report noting key changes in the deficit forecast which include: an improved outlook on utility costs after re-examining bills for July-October 2019; maximizing use of grants to offset certified salaries and late invoices for additional transportation costs. Mr. Penn noted that the upcoming deficit forecast should decrease substantially in future budget reports.
- Other Contractual Services Report: Mr. Penn reviewed the report, noting that eight vendors make up the majority of spending. He will look at the possibility of adding more information on future reports.
- 2020-2021 Budget Update: Mr. Penn reported that the budget process is underway. Principals and Administrators have submitted staff rosters and preliminary budgets are due from schools and departments by January 8, 2020. Mr. Penn noted that the planning calendar includes community forums. He anticipates a draft budget for review at the January 21, 2020 Finance & Operations Committee meeting and January 27, 2020 Board of Education meeting.
- Budget Mitigation Committee Update: Ms. Leslie Blatteu presented recommendations from the committee. The recommendations will be forwarded to the Board of Education for review.
- Executive Session: On a Motion by Ms. Rivera, seconded by Mr. Goldson, it was unanimously voted to go into Executive Session at 6:12 p.m., for the purpose of discussing statements of strategy or negotiation with respect to collective bargaining for the SAA contract, passed. Ms. Rivera invited Mr. Penn, Mr. Pinto and Dr. Tracey.

On a Motion by Ms. Rivera, seconded by Mr. Goldson to reconvene the Public Session at 6:24 p.m. Ms. Rivera noted that no votes were taken.
