For consideration and approval of the Award of Contract #21554 to **Life Safety SVC & Supply LLC. Cheshire, CT. 06** for On Call Fire Extinguisher Services for NHPS for Fiscal Year 2020-2021.

Amount of Contract: Not to exceed \$25,000.
