–Dr. Michele Sherban, Mr. John Nguyen, & Ms. Gemma Joseph- Lumpkin	Attendance data provided is from AESOP. In 2021 the year began remotely with a low attendance and increased thereafter. There was a difference this year among the grade levels. On average 6-7% teachers were absent each day and slightly increase for high school teachers.
	Student attendance – A student is considered chronically absent if they miss 10% or more of their enrollment days.
• Fall Assessment Update – Dr. Michele Sherban	Strategies for student groups – Ms. Joseph-Lumpkin reported chronic absenteeism had been observed among the 0-1 days absent (track one) and they are potentially drifting. 6-10 days absent - schools are being trained with school- based mentors, a student success plan is in place along with external mentorship. Home visit and parent collaboration is in effect. Data infrastructure system is been implemented. Sub group date
	Multi-lingual learners – overall chronic absenteeism is 37% and non - multilinguals learners are 63%. Multi lingual learner's chronic absenteeism rate is lower than non-multi-lingual learners. 52% of children with IEP are chronically absent.
