Yes. The Schoolyards Program of Common Ground supports the effective use of school gardens, schoolyard habitats, and outdoor classrooms/spaces in schools and throughout the community. By using their science knowledge and resources to provide professional and technical support, they help schools to realize the full potential of teaching outside in deepening the academic and emotional learning of their students. Common Ground educators will share their expertise with classroom teachers, coaches, paraprofessionals and families during outdoor seasonal field trips and family engagement events. Using the gradual release instructional model, Common Ground staff will model, demonstrate, and co-teach with Head Start staff. Common Ground staff will provide curriculum design and support, as well as facilitated activities aligned to the Creative Curriculum units of study used in the Head Start classrooms, the CT Early Learning Development Standards and the Head Start Early Learning Outcomes Framework. They will facilitate three family engagement events for the 531 Head Start families and students attending Truman School, John S. Martinez, Benjamin Jepson, Fair Haven, Lincoln Bassett, and the Dr. R. Mayo School, Each classroom of 17 students will experience four seasonal field trips throughout the school year. The program is designed to provide authentic and engaging learning opportunities for all stakeholders, building internal capacity in the home, school, and community level.

Yes. The program is designed to provide authentic and engaging learning opportunities for all stakeholders, building internal capacity at the home, school, and at community level. Teachers, staff, students and families will be learning side by side. Demonstrations, explorations, modeling and questioning strategies will be able to be replicated in new contexts by family members as

well as teaching staff. Students will develop inquiry and higher-level thinking skills that can be transferred to future learning experiences.

### 8. Contractor Selection:

a. What specific skill set does this contractor bring to the project? If a new contractor, please attach a copy of the contractor's resume.

The contractor is a New Haven Public Charter School. The Schoolyards Program is a community program of Common Ground High School, Urban Farm and Education Center. The program employs certified teachers and professionals with graduate degrees in environmental studies and extensive experiences in outdoor learning, school gardens, habitats, and makerspaces. Many of the staff members have led outdoor learning programs with children and adults throughout New England.

- In 2012, the Connecticut School Garden Resource Center was launched through a partnership between Common Ground and the Green Village Initiative, an organization that has started school gardening efforts across Bridgeport and Westport.
- Through a partnership with Audubon Connecticut, the U.S. Fish and Wildlife Service, and New Haven Public Schools, this work grew to include schoolyard habitats, as well as edible gardens.
- Today, the School Garden Resource Center provides professional development, infrastructure support, networking opportunities, and other resources to a network of more than a dozen New Haven Public Schools — while also supporting like-minded efforts across Connecticut.

Cost, proximity, quality of staffing, scope of services, resources and flexibility made this contractor more desirable than any alternate sources.

### 9. Evidence of Effectiveness & Evaluation

What <u>specific need</u> will this contractor address and how will the contractor's performance be measured and monitored to ensure that the need is met?

This project is designed to enhance the learning experience for all New Haven Head Start students in science as well as strengthen the teaching staff's (lead teachers, paraprofessionals, coaches, assistant teachers, and part-time assistants) instructional practices in the areas of science, social emotional learning, language arts and mathematics and how these relate to the CT Early Learning and Development Standards. The project is also intended to provide learning opportunities for families to deepen their understanding on how to further support their children's learning and strengthen the home-school connection, foster relationships and build a cooperative learning community with teachers, children and families learning together. The project is intended to build engagement by extending learning outdoors and bring the outdoors in.

The contractor's performance will be evaluated using multiple measures; through number of children and families' attendance, at family engagement events, staff evaluations upon completions of field trips, and parental/family feedback. Student outcomes will be progress monitored for growth with the below goals targeted:

- · 80% of children will demonstrate progress in scientific reasoning from Fall of 2021 to Spring of 2022 as measured by the Desired Results Developmental Profile (DRDP)
- · 80% of children will demonstrate progress in language and communication from Fall of 2021 to Spring of 2022 as measured by the Desired Results Developmental Profile (DRDP)
- · 80% of children will demonstrate progress in literacy from Fall of 2021 to Spring of 2022 as measured by the Desired Results Developmental Profile (DRDP)
- · 80% of children will demonstrate progress in social emotional learning from Fall of 2021 to Spring of 2022 as measured by the Desired Results Developmental Profile (DRDP)
- · 80% of children will demonstrate progress in mathematical reasoning from Fall of 2021 to Spring of 2022 as measured by the Desired Results Developmental Profile (DRDP)

The project addresses the goals of increasing student achievement, culture, climate as well as family and community engagement. This proposal utilizes highly engaging natural materials/environment and lessons to deepen teacher practice, family engagement and student achievement. New Haven Head Start will maintain fidelity to Head Start Program Performance Standards by utilizing Creative Curriculum as the curriculum for the Head Start program for the 2020-2021 school year and enhancing units with authentic inquiry-based learning through highly qualified science partners. The project will utilize the expertise of Common Ground partners for on and off-site field trips as well as the facilitation of family evenings. The goals are aligned to the NHPS District's Strategic Plan goal number one.

Strong Foundation in Early Learning: If we assure that all students receive high quality early childhood experiences, focusing on appropriate Child Developmental Strategies, then all students will have the necessary skills to meet their personal growth targets.

- · By 2024 80% of Pre-K-3 students with uninterrupted learning will meet or exceed grade level literacy and math benchmarks.
- · By 2024 100% of students will meet or exceed grade level growth expectations.
- $\cdot$  By 2024 100% of elementary schools and 85% of all PreK-3 classrooms will have fully implemented play-based/inquiry-based learning.

- 10. Why do you believe this Agreement is fiscally sound?

  This agreement is fiscally sound because it has been budgeted for in the State Head Start Innovative Enhancement Grant with the goal of enhancing students' learning in science, mathematics, and social emotional learning. The learning connects the local natural environment and community together making it relevant and meaningful.

# AGREEMENT By And Between The New Haven Board of Education AND

### FOR DEPARTMENT/PROGRAM:

Early Learning: New Haven Public Schools Head Start Program

This Agreement entered into on the 13th day of September 2021, effective (<u>no sooner than the day after Board of Education Approval</u>), the 14th day of September 2021, by and between the New Haven Board of Education (herein referred to as the "Board") and, Common Ground High School, Urban Farm & Environmental Education Center located at 358 Springside Avenue, New Haven, CT 06515 (herein referred to as the "Contractor".

**Compensation:** The Board shall pay the contractor for satisfactory performance of services required the amount of \$800 per session, for a total of <u>3</u> family engagement sessions and \$135 per classroom field trip for a total of 4 field trips for 32 Head Start classrooms.

The maximum amount the contractor shall be paid under this agreement: nineteen thousand, six hundred eighty dollars (\$19,680). Compensation will be made upon submission of <u>an itemized</u> invoice which includes a detailed description of work performed and date of service.

### EXHIBIT B

### STUDENT DATA PRIVACY AGREEMENT SPECIAL TERMS AND CONDITIONS

For the purposes of this Exhibit B "directory information," "de-identified student information," "school purposes," "student information," "student records," "student- generated content," and "targeted advertising" shall be as defined by Conn. Gen. Stat.§10-234aa.

- 1. All student records, student information, and student-generated content (collectively, "student data") provided or accessed pursuant this Agreement or any other services agreement between the Parties are not the property of, or under the control of, the Contractor.
- 2. The Board shall have access to and the ability to delete student data in the possession of the Contractor except in instances where such data is (A) otherwise prohibited from deletion or required to be retained under state or federal law, or (B) stored as a copy as part of a disaster recovery storage system and that is (i) inaccessible to the public, and (ii) unable to be used in the normal course of business by the Contractor. The Board may request the deletion of any such student information, student records or student-generated content if such copy has been used by the operator to repopulate accessible data following a disaster recovery. The Board may request the deletion of student data by the contractor within two (2) business days of receiving such a request and provide to the Board confirmation via electronic mail that the student data has been deleted in accordance with the request, the date of its deletion, and the manner in which it has been deleted. The confirmation shall contain a written assurance from the Contractor that proper disposal of the data has occurred in order to prevent the unauthorized access or use of student data and that deletion has occurred in accordance with industry standards/practices/protocols.
- 3. The Contractor shall not use student data for any purposes other than those authorized pursuant to this Agreement.
- 4. A student, parent or legal guardian of a student may review personally identifiable information contained in student data and correct any erroneous information, if any, in such student data. If the Contractor receives a request to review student data in the Contractor's possession directly from a student, parent, or guardian, the Contractor agrees to refer that individual to the Board and to notify the Board within two (2) business days of receiving such a request. The Contractor agrees to work cooperatively with the Board to permit a student, parent, or guardian to review personally identifiable information in student data that has been shared with the Contractor, and correct any erroneous information therein.

- 5. The Contractor shall take actions designed to ensure the security and confidentiality of student data.
- 6. The Contractor will notify the Board, in accordance with Conn. Gen. Stat. § 10-234dd, when there has been an unauthorized release, disclosure or acquisition of student data. Such notification will include the following steps:

Upon discovery by the Contractor of a breach of student data, the Contractor shall conduct an investigation and restore the integrity of its data systems and, without unreasonable delay, but not more than thirty (30) days after such discovery, shall provide the Board with a more detailed notice of the breach, including but not limited to the date and time of the breach; name(s) of the student(s) whose student data was released, disclosed or acquired; nature of and extent of the breach; and measures taken to ensure that such a breach does not occur in the future.

- 7. Student data shall not be retained or available to the Contractor upon expiration of the contract between the Contractor and Board, except a student, parent or legal guardian of a student may choose independently to establish or maintain an electronic account with the Contractor after the expiration of such contract for the purpose of storing student-generated content.
- 8. The Contractor and Board shall each ensure their own compliance with the Family Educational Rights and Privacy Act of 1974, 20 U.S.C. § 1232g, as amended from time to time.
- 9. The Contractor acknowledges and agrees to comply with the above and all other applicable aspects of Connecticut's Student Data Privacy law according to Connecticut General Statutes §§ 10-234aa through 10-234dd.
- 10. The Parties agree that this Agreement controls over any inconsistent terms or conditions contained within any other agreement entered into by the Parties concerning student data.
