Other: (Please describe) Often, learners of French may get the impression that French is Paris and baguettes, exclusively; however, the French language is spoken in many other countries, including many countries in Africa. This learning experience for students and teachers will help them to connect with French-speaking Africa, especially Senegal, by interacting with actual students there while learning about traditional dance and drumming. Dr. Diop will provide professional development for French teachers at James Hillhouse, Clemente, and King Robinson. In addition, she will coordinate and oversee an online exchange between students at James Hillhouse HS and a school in Senegal. She will provide cultural, dance, and drumming lessons to students at all three schools and help the World Languages Supervisor to organize an "Africa is Me" event for the entire school in the late spring.

She will be able to provide guidance to our French teachers on teaching about Africa and facilitate our online exchange with students in Senegal, as well as dance lessons and drumming demonstrations. She has extensive knowledge of school culture in Senegal and the New Haven community. Her resume is attached.

We had been engaged in conversations about how to facilitate a relationship between Senegal and NHPS learners of French. I requested a quote for her services to facilitate the exchange, dance and drumming lessons, and coordination of an event.

Often, learners of French may get the impression that French is Paris and baguettes, exclusively; however, the French language is spoken in many other countries, including many countries in Africa. In addition, students might not have an updated understanding of modern Africa. This learning experience for students and teachers will help them to connect with French-speaking Africa, especially Senegal, by interacting with actual students there in an online exchange. Students will also learn about traditional dance, drumming, and other cultural practices. This experience will enhance student motivation to communicate in French and see it as an international language. The effectiveness of this experience will be measured via teacher survey and student survey at the end of the year, as well as observation by the Supervisor.

- c. How is this service aligned to the District Continuous Improvement Plan? When students see first-hand evidence of the world beyond New Haven, through interactions with students in Senegal, it enhances their ability to achieve in all of the Humanities. World languages, history, English, and the Arts require that students have an awareness of other countries, cultures, and beliefs. In lieu of international travel, this type of peer-to-peer exchange and cultural study is the best way to show students the world.
- 12. Why do you believe this Agreement is fiscally sound? The hourly rate is very reasonable for the expertise and services rendered.
- 13. What are the implications of not approving this Agreement? French class students and teachers would miss out on this opportunity to learn about and exchange with students in Senegal. All students at James Hillhouse would miss the opportunity to connect with Africa through the planned "Africa and Me" event.

EXHIBIT B

STUDENT DATA PRIVACY AGREEMENT SPECIAL TERMS AND CONDITIONS

For the purposes of this Exhibit B "directory information," "de-identified student information," "school purposes," "student information," "student records," "student- generated content," and "targeted advertising" shall be as defined by Conn. Gen. Stat.§10-234aa.

- 1. All student records, student information, and student-generated content (collectively, "student data") provided or accessed pursuant this Agreement or any other services agreement between the Parties are not the property of, or under the control of, the Contractor.
- 2. The Board shall have access to and the ability to delete student data in the possession of the Contractor except in instances where such data is (A) otherwise prohibited from deletion or required to be retained under state or federal law, or (B) stored as a copy as part of a disaster recovery storage system and that is (i) inaccessible to the public, and (ii) unable to be used in the normal course of business by the Contractor. The Board may request the deletion of any such student information, student records or student-generated content if such copy has been used by the operator to repopulate accessible data following a disaster recovery. The Board may request the deletion of student data by the contractor within two (2) business days of receiving such a request and provide to the Board confirmation via electronic mail that the student data has been deleted in accordance with the request, the date of its deletion, and the manner in which it has been deleted. The confirmation shall contain a written assurance from the Contractor that proper disposal of the data has occurred in order to prevent the unauthorized access or use of student data and that deletion has occurred in accordance with industry standards/practices/protocols.
- 3. The Contractor shall not use student data for any purposes other than those authorized pursuant to this Agreement.
- 4. A student, parent or legal guardian of a student may review personally identifiable information contained in student data and correct any erroneous information, if any, in such student data. If the Contractor receives a request to review student data in the Contractor's possession directly from a student, parent, or guardian, the Contractor agrees to refer that individual to the Board and to notify the Board within two (2) business days of receiving such a request. The Contractor agrees to work cooperatively with the Board to permit a student, parent, or guardian to review personally identifiable information in student data that has been shared with the Contractor, and correct any erroneous information therein.

- 5. The Contractor shall take actions designed to ensure the security and confidentiality of student data.
- 6. The Contractor will notify the Board, in accordance with Conn. Gen. Stat. § 10-234dd, when there has been an unauthorized release, disclosure or acquisition of student data. Such notification will include the following steps:

Upon discovery by the Contractor of a breach of student data, the Contractor shall conduct an investigation and restore the integrity of its data systems and, without unreasonable delay, but not more than thirty (30) days after such discovery, shall provide the Board with a more detailed notice of the breach, including but not limited to the date and time of the breach; name(s) of the student{s) whose student data was released, disclosed or acquired; nature of and extent of the breach; and measures taken to ensure that such a breach does not occur in the future.

- 7. Student data shall not be retained or available to the Contractor upon expiration of the contract between the Contractor and Board, except a student, parent or legal guardian of a student may choose independently to establish or maintain an electronic account with the Contractor after the expiration of such contract for the purpose of storing student-generated content.
- 8. The Contractor and Board shall each ensure their own compliance with the Family Educational Rights and Privacy Act of 1974, 20 U.S.C. § 1232g, as amended from time to time.
- 9. The Contractor acknowledges and agrees to comply with the above and all other applicable aspects of Connecticut's Student Data Privacy law according to Connecticut General Statutes §§ 10-234aa through 10-234dd.
- 10. The Parties agree that this Agreement controls over any inconsistent terms or conditions contained within any other agreement entered into by the Parties concerning student data.

Scope and Sequence:

Overview: Students in French classes at James Hillhouse High School, King Robinson, and Roberto Clemente will have the opportunity to learn about the culture, dance, and language(s) of French-speaking Africa, facilitated by Dr. Hanan Hameen, of the Artsucation[™] Academy Network and Ms. Hanan's Dance and Beyond, and partner teachers in Senegal. Students at Hillhouse will practice the French language during the 2023-2024 school year through a virtual language and cultural exchange with schools in Senegal beginning in September 2023. Dr. Hameen will also provide instruction in African Dance and Culture to French classes at James Hillhouse High School (grades 9-12), King Robinson (grades 6-8), and Clemente Leadership Academy (grades 7-8), with a final culminating activity for all students in May of 2024. The teachers of the French students will participate in professional development workshops with follow-up sessions with Dr. Hanan Hameen to assess student involvement and curriculum implementation to support the cultural exchange.
