# LETTER FROM THE DIRECTOR

Dear Friends:

We are pleased to present the 2023-2024 Annual Report for New Haven Public Schools Head Start. The following report highlights our program's accomplishments, activities, and outcomes for the children and families of the City of New Haven.

The 2023-2024 school year was very exciting in that the children continued to experience play-based learning with their peers and develop positive attitudes about learning. The past year was marked by outstanding activity and achievement. Our program effectively showcased its capacity to implement a high-quality program aimed at positive outcomes and enhanced school readiness for children and their families.

We successfully competed for the Head Start Grant in the New Haven Service Area and received the award in July of 2024, for another five-year period. Led by new leadership – Superintendent Dr. Madeline Negrón and Director of Early Learning Programs Ms. Vanessa Diaz-Valencia – NHPS proposed a reimagined program design and restructuring of Head Start, which:

- Offers increased slots in the areas of greatest need [Fair Haven];
- Provides salaries for early care and education staff that far exceeds the living wage that covers basic necessities
- Better leverages district funding [nearly \$2 million in additional resources for children and families enrolled in the Head Start program]; and
- · Extends a management structure for solid oversight of the program

We continued to provide Head Start's comprehensive services to all stakeholders. The school-based health center that was established in collaboration with Cornell School Hill Health delivered medical and dental services to our Head Start students. Throughout the year, our dedicated full-time in-house mental health clinicians consistently provided support to our students, teachers, and staff during the year. The program also centralized and streamlined the registration process. Using modern technologies, we encouraged and assisted families in applying for admission to the program and reduced the families' paperwork burden in the application and enrollment process. This efficient process also provides families with a seamless transition to kindergarten.

We're eagerly anticipating another exciting school year. Our plans include the opening of additional classrooms in the community. New classrooms will be available to families at the Family Academy of Multilingual Exploration, Lincoln Bassett, and Hill Central schools. These classrooms are distributed strategically throughout the city to cater to families living within walking distance. This allows all siblings the opportunity to attend the same school Pre-K through eighth grade. Additionally, we will be providing professional development support for educators, utilizing LETRS for Early Childhood Educators, a course that will deepen their understanding of early language and literacy development, as well as, the impactful instructional practices that will ensure our students' kindergarten readiness. Our goal remains steadfast: to provide a nurturing environment that supports early learning development, health, and family engagement. Our mission is achieved through collaborative partnerships involving all stakeholders.

We encourage you to explore our New Haven Public Schools Head Start Program. Discover the distinctive home-school relationships that set our program apart and contribute to our consistently achieved positive outcomes.

## MISSION STATEMENT & PHILOSOPHY

New Haven Public Schools Head Start believes that quality early childhood education is essential to future school success and offers quality childcare to all children regardless of family structure; socioeconomic, racial, religious, and cultural backgrounds; gender; abilities; or preferred language. The goal of the early childhood program is to ensure that all children in New Haven will enter kindergarten ready to learn. Our educational program is designed to help children develop socially, cognitively, physically, and emotionally in a nurturing and safe environment.

In our effort to address the needs of the whole child New Haven Public Schools Head Start offers comprehensive services in the varied areas of health and social services to families directly or through a referral system. New Haven Public Schools Head Start also recognizes the family as central to the well-being of the child. We believe that fostering a strong home/school/community partnership is central to meeting the needs of children and their families. Our goal is to help families become informed advocates for children's education and to be integral partners in the educational process, including all aspects of program design, operation, and evaluation. New Haven Public Head Start works intentionally to foster strong reciprocal relationships with families from the initial contact and endeavors to maintain these relationships over time.

New Haven Public Schools Head Start values and celebrates diversity. We understand that children's optimal development and learning hinges on our acceptance of children's home language, respect and value for children's home culture, and the promotion and encouragement of involvement and support of all families, including extended and non-traditional family units. Classrooms and curricula are designed to accommodate the individuals that make up our community. We seek information from each family about their culture and home language and strive to incorporate this information into all aspects of our program.

Continued to fund a schoolbased health center in partnership with Cornell Scott Hill Health Center to provide onsite medical and dental services to Head Start students.







#### **Head Start Bus Policy and Protocols**

#### **RESPONSIBILITIES OF SCHOOL-Dr. Reginald Mayo School**

A.M.-

Students disembark from bus with support, in well supervised area

Classroom personnel collect their assigned children and check them in on their classroom bus roster

Children are walked to classroom and checked in again, walkers and bus students are merged onto active supervision roster for the day

P.M.-

Students exit classroom with supervising adults, walkers and bus students are separated

Supervising adults check off students as they board the bus, utilizing the morning bus roster

#### School Leadership-

School remains staffed to receive any telephone calls or bus inquiries until receiving notification that all buses have cleared

School will assume responsibility for notifying families that their children being returned to school

School is responsible for receiving and actively supervising all returned students

School will verify the authorization of any adult picking up a returned child, requesting photo identification if necessary

School will notify the Head Start Director immediately of any bus related incidents

#### **RESPONSIBILITIES OF PARENTS of Pre-school Aged Children**

1. Parents/guardians will sign and agree to terms of Head Start Bus Policy.

2. Parents/guardians are expected to have students ready at least ten (10) minutes prior to the scheduled pick up time. Parents/guardians are expected to be at bus drop off ten (10) minutes prior to the scheduled drop off time.

3. Parents are expected to receive children or arrange to have a designated adult with photo identification at the bus drop off point. If a child is returned to school because no one received him/her or the receiving adult is not listed or does not have proper identification, it is the parent's responsibility to arrange transportation home.

4. Home/cell telephone numbers and at least one emergency number must be made available to your child's school. Families will complete the emergency pickup authorization form and will accept responsibility for updating as needed.

5. In the event there is a family crisis, parents must assume the responsibility for notifying school officials and arranging alternative plans for pickup of child returned to the school.

#### **RESPONSIBILITIES OF BUS MONITORS of Pre-school Aged Children**

- 1. Bus monitors will check students onto the bus each morning.
- 2. Bus monitors will secure each student into their five-point harnessed car seat.
- 3. Bus monitors will check students onto the bus each afternoon at dismissal
- 4. Bus monitors will have an identified adult sign for the child at the bus stop when dropping off.
- 5. Bus monitors will return signed pick up sheets to the Dr. Mayo School the following day.

#### **STEPS to Prevent Inappropriate Release**

When an unknown adult is at the bus stop:

- Ensure the person picking up is over 18 years of age.
- Request picture identification.
- Verify permission authorizing release of child to the adult- check transportation authorization form can be verified through PowerSchool portal
- Call the Dr. Reginald Mayo School if assistance is required
- If verified, release child and obtain signature
- If the adult is not authorized, call First Student base/ dispatch and Dr. Mayo School to notify them child will be returned to school
- Return child to the school, obtain signature from receiving school staff

When a bus stop/drop off location is in question:

- Check the run sheet for drop off location
- Call First Student base to ensure there are no updates or changes to the run sheet
- Call the Dr. Mayo School to verify there are no extenuating circumstances
- Do not release student at any unauthorized location/facility or to any adult not listed on pick up authorization form
- Return student to Dr. Reginald Mayo School
